6 Remarks

Period of Validity

Quality Management, Accreditation And Notification

All tests and services are performed under a quality management system according to EN ISO/IEC 17025 respectively EN ISO/IEC 17065. TESTEX is accredited as Testing Laboratory and Certification Body for products as well as Notified Body (NB1724). (see http://ec.europa.eu/enterprise/newapproach/nando/). Accreditation was provided by National Swiss Accreditation Body (SAS). The scope of accreditation is listed on www.testex.com. Due to the system for the mutual recognition of national accreditations (ILAC/IAF), this accreditation is valid worldwide. In this report individual non-accredited test procedures are marked with *. However, the analysis was also carried out for these parameters at the same level of quality as for the accredited parameters. According to the decree on the use of the accreditation mark (AkkBV") the accredited Conformity Assessment Body is the only one to use the accreditation mark. Application of the registration number of the Notified Body: As to personal protective equipment (PPE) the requirements of PSAV, article 3, paragraph 3 and the Regulation (EU) 2016/425 have to be kept. With construction products the application is only permitted within the declaration of performance for CE-marking.
